Proper conduct and language must be observed at all times.

The Prescott Curling Centre Inc. will not be responsible for any damage to or loss of any articles left in the Club, prior to, during or following any function by the Customer or his/her agent.

Alcoholic beverages will be served in accordance with the regulations of the Liquor Control Board of Ontario. No alcoholic beverages may be taken beyond the lounge. No "personal" alcoholic beverages are permitted in or on the premises of the Prescott Curling Centre Inc.

It is understood that the \$100.00 deposit is required when the agreement is signed and will be fully refundable if the rental is cancelled prior to 30 days' notice before the event.

It is understood that if the rental is cancelled after the 30 days, the deposit is non-refundable.

It is understood that kitchen rental does NOT include use of the dishwasher.

It is understood that there is a \$100.00 CLEANING DEPOSIT, refundable pending a post rental inspection.

Failure to adhere to any or all terms and conditions may jeopardize any future association with the Prescott Curling Centre Inc.

Rental of the Prescott Curling Club is by mutual agreement between the Prescott Curling Centre Inc. and the Customer. The Prescott Curling Centre Inc. reserves the right to refuse rental for any reason.
